Board members held a moment of silence in honor of Rob Raudenbush who was serving a term as Township Supervisor and passed away on April 6 , 2025

Chairman – School taxes update

Vice Chairman/Roadmaster – Watching for and fixing potholes. Plows have been taken off trucks. Start refilling the cinder shed over the summer months.

EMA – Hazard Mitigation plan updated every 5 years high risk lowest risks assessments.

New Business: Supervisor Johnston made a motion to appoint Debra Pier Supervisor to fill Supervisor Raudenbush vacancy seconded by Supervisor Nissly, (MCU). Supervisor Johnston made a motion to schedule Midland Asphalt EDP Dust Oil to treat the roads seconded by Supervisor Nissly (MCU). The township purchased a cell phone for the office. Permit officer supplies were discussed, and Supervisor Nissly would like to start doing the zoning paperwork

process digitally. Supervisor Johnston made a motion to advertise for the 2025 stone bid contract second by Supervisor Nissly, (MCU). Supervisor Nissly made a motion for the township to contact solicitor Marc Drier to help with networking with various government agencies with the recovery of the waterways impacted from Tropical Storm Debby capped at 40 hours seconded by Supervisor Johnston, (MCU).

Old Business: RKK SR 284 Blacks Creek Municipal Officials Response Form Debbie and Denny will work on filling out and return. Supervisor Johnston made a motion to give Del Elder a donation of \$1,500.00 as a total and final amount for expenses he incurred with his own equipment, fuel, and time assisting the township with the flood clean up in the aftermath of Tropical Storm Debby August 2024 seconded by Supervisor Pier, (MCU).

General Public Comment Session: Christopher Gleen had questions navigating township zoning and permitting.
