Minutes:

Supervisor Teed made a motion to accept the minutes as written for the Regular Meeting on July 8, 2021 and the Treasures Report for July 2021 seconded by Supervisor Nissly, (MCU).

Reports:

PennDOT representatives were in attendance to get recommendations from the Supervisors on treating hot spots on the Wilson Hill Road being used as a detour. PennDOT is looking into paving at the intersection but want to know if the township wants to have it removed after the detour is over or leave it in. If the Supervisors do want it left in after detour, PennDOT asked if township would be willing to help with some of the expense of putting it down. Supervisor Johnston asked PennDOT to write up a proposal on the cost and time frame it could be done before the township could make any decisions.

Chairman Report / Roadmaster – Replaced pipes on Big Run Rd and Love Rd, will be cutting and mowing at the intersection of Wilson Hill Rd, and fixing stop sign.

Vice Chairman Report – N/A

EMC- Suggested that the Supervisors send a letter of support to keep the English Center Community Building. Supervisor Nissly is not familiar with the building and would like more information.

New Business: Supervisor made a motion to accept the estimate from Chilson Bros, LLC to remove old built-in gutters from township building and install seamless gutters with downspouts and fix gable ends of cap metal with new. For total of \$5,000.00 seconded by Supervisor Teed (MCU). County Aide completion report was signed. Supervisor Johnston made a motion to have work done on the township septic tank seconded by Supervisor Nissly, (MCU).

Supervisor Nissly asked if Township Solicitor, Denise Dieter, will need to be replaced after election. Supervisor Johnston will call Drier and Dieter law office.


Old Business: Two bids were received for the 1996 Chevrolet Kodiak dump truck John Deeme bid \$4,500.00 and Louis Grant bid \$5,001.00. Supervisor Nissly made a motion to accept the higher bid by Louis Grant seconded by Supervisor Teed, (MCU). Supervisor Nissly made a motion to retain the service of McNerney, Page and Hall law firm to address Wellsboro School District disparity in taxes paid by Pine Township Lycoming County residents when Pa Act 1 was not followed seconded by Supervisor Johnston, (MCU). 1410 Oregon Hill Road SEO repair permit received. Tabled coronavirus state and local recovery funds usage until more information is looked over. Supervisor Nissly motioned to have 2 emergency lights added to the work of the automatic transfer switch and lighting up to \$500.00 seconded by Supervisor Teed, (MCU).

Correspondence: Lycoming County Tax Claim Office asks for pre-registration for upset tax sales and judicial sales to avoid instances with liens or delinquent taxes. The tax office will notify the township five days prior to date of sales to verify anything outstanding in its boundaries. PSATS, beginning August 29, townships will be required to post meeting agendas at least 24 hours before each meeting on the township's website, if the township has one, and at the meetings location. (2) PA Dept of Environmental Protection receipt of notification of general permit Jack Cammalls Camp Run Bridge. Receipt of final report Schneider National Bulk Carriers PA 287 diesel fuel cleanup. PA COSTARS delay in issuing the 2021-2022 Road Salt contract.

General Public Comment Session: Todd Lauer had questions on the township's road bonding permits process and road weight restrictions on Wilson Hill Road. The secretary gave him Municipal Solutions number to contact for the information he requested. They are the townships posting authority. Several residents were in attendance with a petition requesting that the township supervisors initiate the process to approve an ordinance allowing ATVs on township roads. Supervisor Nissly made a motion to advertise in the paper that the next regular meeting is open to all township residents and landowners to attend and to voice questions, comments, or concerns before moving ahead.

Payment of Bills: Supervisor Johnston made a motion to pay bills in the amount of: General Fund \$25,608.77; Highway Aid Fund; \$ 2,388.23; Equipment Fund \$0.00; Gas Impact Fund \$0.00 seconded by Supervisor Teed (MCU).
