Minutes:

Supervisor Johnston made a motion to accept the minutes as written for the Regular Meeting held on June 12, 2025 and the Treasurer's Report for June 2025, seconded by Supervisor Pier, (MCU).

Reports:

DCNR Chief Ranger Bureau of Forestry attended the meeting to discuss problems they have been having with ATVs on State Game Lands and State Forest Lands coming from Pine Township. Township ATV signage is not adequate. In summary, the townships is responsible for installing and maintaining traffic control devices . This includes replacing damage, missing, or outdated signs . The townships signage has been getting stolen especially where it should mark END to ATV's to stop riding on non-designation township roads. The township will order new signage and erect to provide this information to road users, and a statement will be added to the townships webpage with a reminder that the operation of All Terrian Vehicles (ATV's) is strictly prohibited, except on those roads specifically designated and posted for such use.

Chairman -

Vice Chairman/Roadmaster – 2 permits. Trucks inspections are coming due. 1B stone left over from the tar and chipping project will be mixed in with the cinders for the upcoming winter season.

3rd Chair – SAM.gov renewal problems. Morris Townships extended an invitation to the township employees for retirement party they are having for one of their long-time employees.

EMA – HMP Book .National Flood Manual that County does FEMA will review. Residents from English Center asked about the process and how to proceed to get a warning siren for their community.

New Business: English Run Road Dirt & Gravel Grant was approved. Greco Road will be getting some road work. Flood recovery report from Drier Law Office that Supervisor Nissly initiated to help the English Center residents gain attention they deserve from the greater bureaucracy to remedy critical concerns due to last year's flood.

Old Business: Lycoming County Pre-Release Center will with a plan that Supervisor Raudenbush talked about with them before his passing will begin in mid-July work of removing debris piles of logs and brush left over from the Tropical Storm Debby . The township will not be adopting the Regional Solid Waste Plan for Lycoming County as the Township already has its own Permit by Rule approved in accordance with DEP's regulatory requirements for Rural Transfer Facilities, with conditions:
