

ORDINANCE NUMBER 12.09.21

AN ORDINANCE OF THE TOWNSHIP OF PINE, LYCOMING COUNTY, PENNSYLVANIA, REGULATING THE DESIGNATION OF TOWNSHIP ROADS TO BE SHARED BY ATVS AND VEHICULAR TRAFFIC

WHEREAS, the Board of Supervisors of Pine Township has determined that it is in the best interest of the residents of Pine Township to enact a "Joint Use/ATV" road designation ordinance; and

WHEREAS, the Board of Supervisors of Pine Township has determined that unregulated roads for shared use by ATVs and vehicular traffic poses a potential health, welfare, and safety concern; and

WHEREAS, the Board of Supervisors of Pine Township are authorize to enact this ordinance pursuant to the Second Class Township Code and the Pennsylvania Vehicle Code.

NOW, THEREFORE, be it ORDAINED and ENACTED by the Board of Supervisors of Pine Township, as follows:

Section 1. Purpose

The purpose of this Ordinance is to designate **all** township roads in Pine Township as ATV roads, to permit the roads to share all-terrain vehicle (ATV) and vehicular traffic.

Section 2. Definitions

The term ATV or "all-terrain vehicle" shall be defined as set forth in the Motor Vehicle Code of the Commonwealth of Pennsylvania, as amended and supplemented.

Section 3. Designation

All roads owned and maintained by Pine Township are hereby designated "Joint Use/ATV" roads to permit the roads to be shared by ATV and vehicular traffic.

Section 4. Liability

In accordance with the Motor Vehicle Code of the Commonwealth of Pennsylvania, as amended and supplemented (see 75 Pa. C.S.A. § 7722), Pine Township assumes no liability whatsoever because of designating any of the aforesaid township roads to be shared by ATV and vehicular traffic.

SEVERABILITY. Should any section of this Ordinance or part thereof be declared invalid by a court of competent jurisdiction, such invalidity shall not affect the balance of Ordinance since it was the intent of the Board of Supervisors that said Ordinance would have been adopted even if such invalid provision had not been included.

REPEALER. All ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

EFFECTIVE DATE. This ordinance shall become effective upon enactment.

**AN ORDINANCE ESTABLISHING SPEED LIMITS FOR MOTOR
VEHICLES ON CERTAIN ROADWAYS WITHIN PINE
TOWNSHIP, LYCOMING COUNTY, PENNSYLVANIA**

WHEREAS, certain roads or streets exist within Pine Township, state owned and township owned, where speed limits have been previously established or a change in conditions has occurred to warrant a reevaluation of the speed limits previously set; and

WHEREAS, Pine Township, in order to advance the welfare and safety of the residents of the township and such other persons who use said streets and roads, deems it necessary to enact speed limitations on certain streets and roads in Pine Township; and

WHEREAS, Pine Township is authorized to enact this ordinance pursuant to the Second Class Township Code and pursuant to the Pennsylvania Code Title 67 Section 212.108 and 75 Pa. C.S.A. Section 3363, and also consented to by the Pennsylvania Department of Transportation.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by Pine Township as follows:

Section 1. The maximum speed limit at which vehicles may proceed on the following roads with Pine Township, during detour times (as specified below) are as follows:

<i>NAME OF HIGHWAY</i>	<i>SPEED LIMIT (mph)</i>	<i>LOCATION</i>
1. Wilson Hill Road	30 mph	from the Pine/Morris Township line to Oregon Hill Road
2. English Run Road	35 mph	entire road

These speed restrictions will be enforced from April 1, 2021 through October 30, 2021 and April 1, 2022 through October 30, 2022 unless otherwise determined by resolution of Pine Township.


Section 2. This ordinance shall be enforced in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.

Section 3. Should any provision of the ordinance be found unconstitutional or otherwise illegal or in any other manner unenforceable, the remaining sections of the ordinance shall remain in full force and effect.

Section 6. This Ordinance shall take effect within 30 days after enactment or the shortest time allowable by law.


