New Business: Flood Disaster Relief Update- Objective to protect human health and safety . Aerial imagery. Updated web page daily. Coordinated, placed and filled 30 roll-off containers flood debris . Data management uploaded to County and tallied weekly expenses to EMS. Door to door with County EMS conducting damage surveys. Coordinated and distributed cleaning supplies. Met with Senator Yaw and Rep. Joe Hamm on site to evaluate damage. Awaiting confirmation from both FEMA and PHEMA to provide financial aid to both municipalities and landowners. The township will address various stream/waterway issues via PE DEP 105 ER permits. Maintained weekly communications with County and Senator Yaw’s office for updates.

Old Business: Dump body on GMC truck will be replaced

Correspondence: PennDOT State Route (S.R.) 4001, Section 049 emergency detour. Lycoming County Tax Office hired Tyler Technologies to conduct reassessment. Larson Design Group will be conducting bridge safety inspections. Pennsylvania Game Commission payment in lieu of taxes.

General Public Comment Session:

Several residents were in attendance and had questions about the measures aimed at fighting flooding and boost stream maintenance. Carol Evens asked the township to identify the risk of the stone that piled up under the Westphal Road bridge from the recent flood event she stated that when talking with PennDOT that a municipality is allowed to clean under and around bridges as part of their regular maintenance 50 feet on either side and asked the township to do a clean out of the risk before the next event occurs.
