Vice Chairman/Roadmaster – Zoning Permits. Winter road cinders

3rd Chair — The township was contacted by the Pa Game Commission inquiring to where the township gets the END ATV SIGNAGE as they would like to get the same signs to post on state game land roads to keep them consistent with what the township puts up. A private lane was being used as a turn around on T-776 English Run Rd for ATV's to avoid the construction zone the township was requested to relocate the END ATV SIGN further up the road to a safer location. This action was the townships efforts to improve the safety of construction workers and the ATV community.

EMA – Hazard Mitigation Plan still a work in progress lots of paperwork and changes.

New Business: Annual equipment maintenance will be scheduled. Sodium Chloride Costars Contact has been received. Supervisor Johnston made a motion to purchase a new copier for the office seconded by Supervisor Pier, (MCU).

Old Business: Mid-Penn Engineering Report- Grant Project Little Pine Creek they are in the final phase of the grant and narrative and will keep the township updated. (Flood Recovery

Report) Drier Law Office is in the process of planning, drafting and refining a written correspondence to the U.S Army Corps of Engineers. Marc Drier reached out to the township for local government and/or public input. The ECCA will act as an intermediary, collecting feedback from residents and consolidate it to pass onto the township to streamline into a more concise format. Westphal stabilization project Lick Run —The project is being funded by Lycoming County Conservation District and Trout Unlimited the update from County Conservation District is project construction will be scheduled when all required permits, the district applied for have been obtained and the trout spawning season has ended. They will be scheduling meetings between Trout Unlimited and the township supervisors to provide updates. County Conservation will attended a board meeting to outline the scope of the project.

Correspondence: Larson Design Group. Lycoming County

General Public Comment Session: Sharon Houser provided information about the new ECCA Facebook that will serve as a central hub for the community to keep updated on events. Kennetta Harper had questions concerning the upcoming election asking about ballot candidates and write in candidates a township is not permitted to provide information about political candidates, she was referred to Lycoming Voter Services and given the contact number. Kennetta Harper asked about the township requesting a review from PennDOT to open a section of Little Pine Creek Road that she is attempting to achieve. The township at this time and given the multiple interpretations of this new PennDOT policy would need more information to understand how it would serve as connector road between trail heads and its feasibility to be approved before committing to a course of action and the expenditure of township funds to determine its viability for potential. A formal request to PennDOT to open a segment of a state highway is not a guarantee and PennDOT has the ultimate authority, and the request is based on specific criteria.
