**Minutes:**

Chairman Report –

Roadmaster Report – Milling repair for Seamen Hill is scheduled to begin September the 26<sup>th</sup>. Supervisor Raudenbush made a motion to order parts and repair dash panel and tie rod ends on the John Deere Tractor seconded by Supervisor Johnston (MCU). New cinder spreader was put on Red GMC Truck. Cleaning out of culverts and pipes this fall.

EMC – NIMS card not received. Iva will send information from meeting she will be attending. The township will call 811 regarding digging to be done on English Run Rd. The township will call the EMC when the road will be closed so she can contact 911. Iva will send slides to the township of presentation she will be attending Update/Change Certification Directive.

**New Business:** Work list will call interested parties to set up interviews. Supervisor Raudenbush made a motion seconded by Supervisor Johnston to order parts and make repairs to the John Deere tractor, (MCU). Anticipated 2023 budget meeting will be on October 17<sup>th</sup> at 7P.M. EMC paperwork tabled until October meeting.

Supervisor Raudenbush made a motion to move forward and accept Hawbak's bid to mill and grade and apply DEP on Seamen Hill after 5 telephone calls and emails were made to qualified contractors for quotations the only other qualified contractor that exist in the market area HRI did not have the availability to do the work with the weather needed to apply DEP others that were asked for quotes for bids never replied back to the township seconded by Supervisor Johnston, (MCU). Supervisor Johnston made a motion to approve the estimate and plan to proceed with Short Sock Industries to start repair of English Run Road seconded by Supervisor Raudenbush, (MCU). American Drug and Alcohol Diagnostics tabled.
